

GOODMAN SCHOLARSHIP POLICY

1. **PURPOSE:** The purpose of scholarships is to:
 - a. Encourage pastors and leaders to have the Emmaus teaming experience.
 - b. Assist spiritual and other leaders that participate in more than one Walk per year (i.e. lay director training positions, music team)
 - c. Provide for those spiritual and others leaders who financially would be unable to attend a walk, after they have sought out scholarships from other sources (reunion groups, sponsors, etc.).

2. **QUALIFICATIONS:**
 - a. Must be qualified to team (has attended Emmaus Walk, Day of Deeper Understanding).
 - b. You may only qualify for assistance once within a past twelve month period of time.
 - d. Applicants are encouraged to seek out funds from other sources (reunion groups, sponsors, churches, etc.)
 - e. Have been asked by the Walk Lay Director to serve on the team but it would be a financial burden (see d. above).

2. **AMOUNT:** The scholarships to be considered for each walk would be supplied out of the Goodman Scholarship Fund and would be as follows:
 - a. Up to \$100 of Walk cost for Emmaus leadership (pastors and other lay personnel.)
 - b. Two full scholarships (\$200) per walk will be offered to those who meet all requirements of the policy.

3. **COMMUNICATIONS:** Requests regarding scholarships will be given to the Scholarship Team using the form provided. The Registrar and the Board Rep of the Walk will make the request. The Registrar, the Board Rep. and the Treasurer will be informed when scholarships are approved.

4. **SCHOLARSHIP FUND:** A scholarship fund will be established and maintained in the amount of approximately \$1200 (assuming Four-full scholarships). The scholarship fund will be replenished by monetary contributions from individuals noting such fund, the Candlelight offerings, from Monthly Gatherings and occasionally, when requested, from Reunion Groups.

5. **SCHOLARSHIP TEAM:** Scholarships will be approved by the Scholarship Team, composed of three designated board members designated as the Scholarship Team, upon a majority vote.

6. **REPORTING:** The Treasurer will report on the status of the Scholarship Fund, in writing, at each Board meeting.

Request for Nancy Goodman Scholarships

Scholarships can be considered for pastors or those in leadership training roles participating in walks more than once a year (refer to Qualifications). Scholarships may be provided up to \$100 for pastors and leaders, and for those in leadership roles. Two full scholarships (\$200) per walk are available to those who meet all requirements of the present policy.
